### KEY RISK

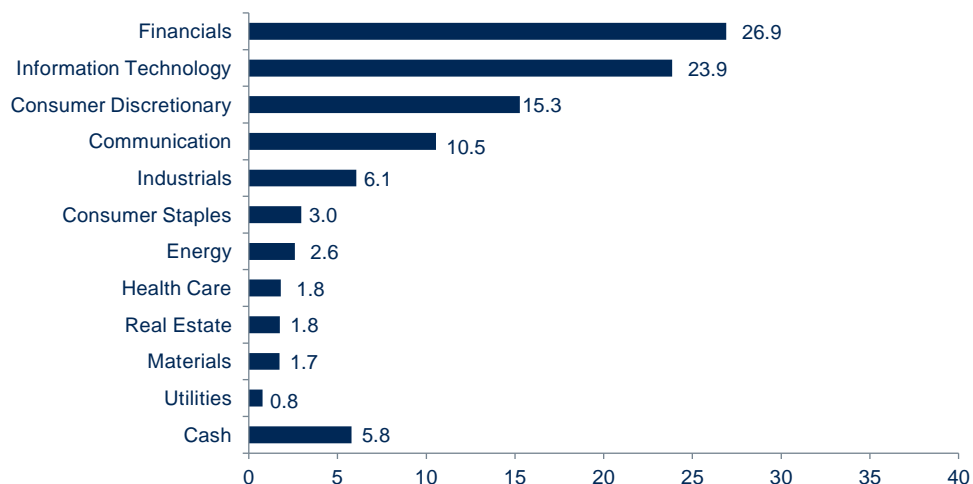

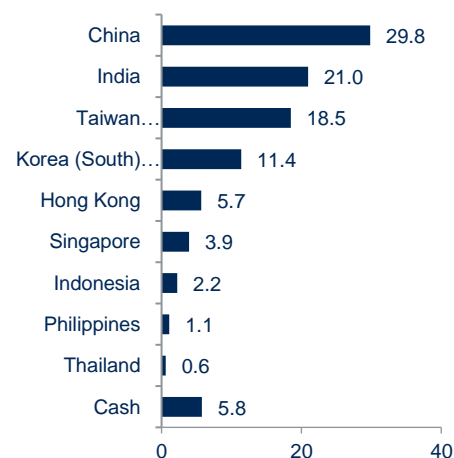
## TOP SECTOR WEIGHTING (% OF MV)<sup>3</sup>
