KEY RISK

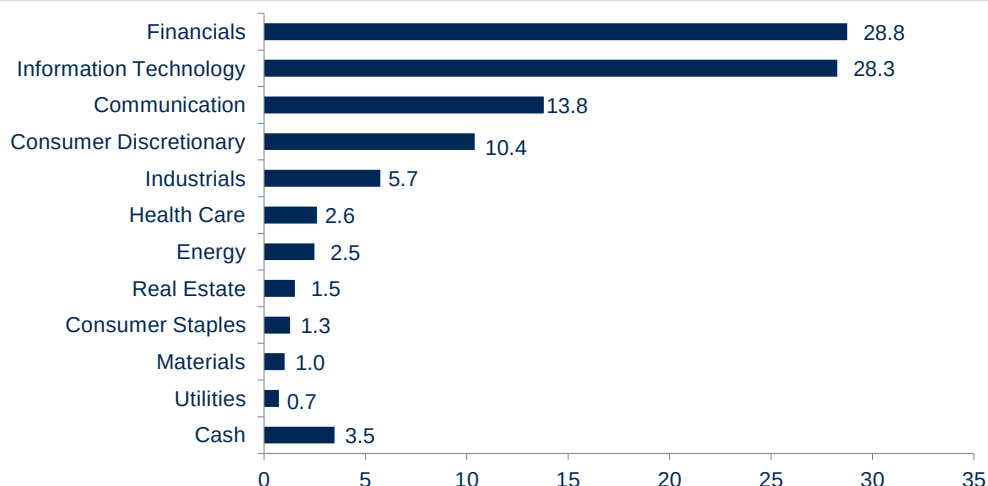
