KEY RISK

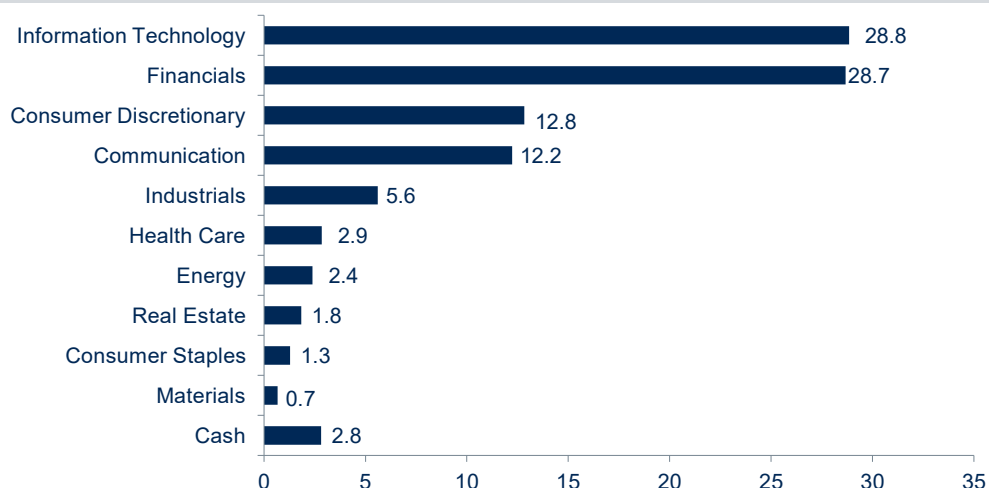
