## MAY 2026 / FACTSHEET

- The Fund invests primarily in high yield fixed and floating rate corporate debt instruments and government debt / sovereign debt instruments globally in developed and emerging/developing markets.
- The Fund is subject to risks relating to investment, credit and counterparty, interest rate fluctuations, volatility and liquidity, downgrading, sovereign debt, valuation, credit rating and currency risks. The Fund's investments are concentrated in sub-investment grade debt instruments which carry greater liquidity and credit risks than investment grade instruments as well as increased risk of loss of principal and interest.
- Investment in emerging/developing markets may involve increased risks, including liquidity, currency risks/control, political and economic uncertainties, legal and taxation, settlement, custody, and volatility risks.

## OBJECTIVE

The Barings Developed and Emerging Markets High Yield Bond Fund ("The Fund") seeks to produce a high level of current income in U.S. dollar terms, commensurate with an acceptable level of risk, as determined by the portfolio managers. Any capital appreciation will be incidental.

## STRATEGY

The Fund will seek to achieve its primary investment objective by investing principally in a portfolio of high yield fixed and floating rate corporate debt Instruments and government debt/ sovereign debt instruments globally. The Fund may invest more than 20% of its Net Asset Value in emerging markets. In order to achieve a high level of current income, the Fund intends to invest principally in high yield securities that are rated not lower than B-. The Fund may invest less than 30% of its Net Asset Value in securities below B-.

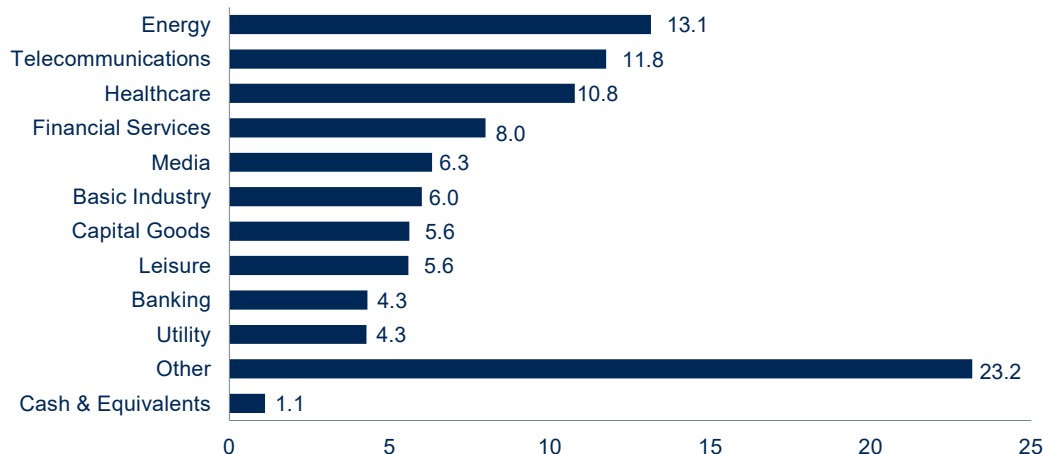

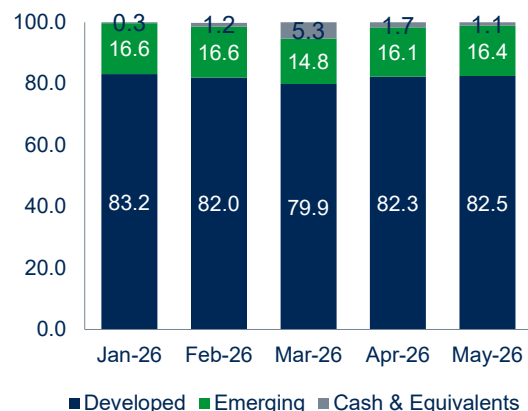
## TOP 10 SECTOR DISTRIBUTION (% OF MV)<sup>4,5</sup>
