- I. The Fund invests primarily in equities and equity-related securities of companies incorporated in, or exercising the predominant part of their economic activity in any European country (including the United Kingdom), or quoted or traded on the stock exchanges in those countries.
- 2. The Fund is subject to risks, such as investment, equities and equity-related securities, liquidity, counterparty, currency risks and the risks of investing in small and mid-capitalisation companies.
- 3. The Fund's investments are concentrated in European markets and the Fund may be subject to higher volatility risk and the sovereign debt risk of certain countries within the Eurozone. 


