3. The Fund's investment may be concentrated in the Hong Kong and China markets and the value of the Fund may be more volatile. 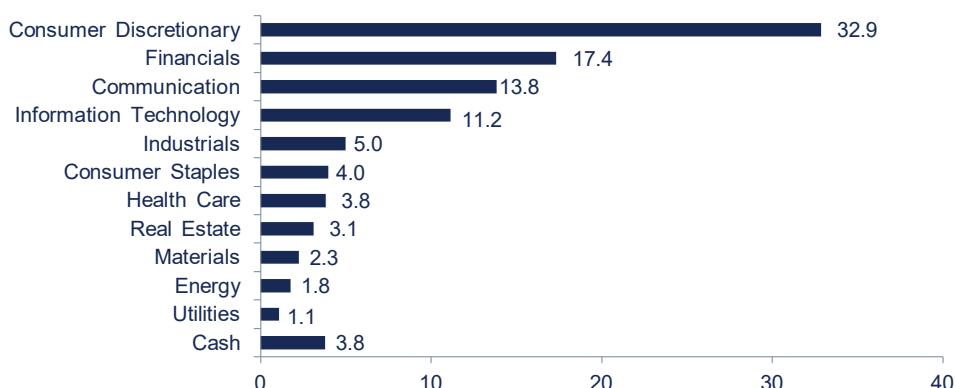

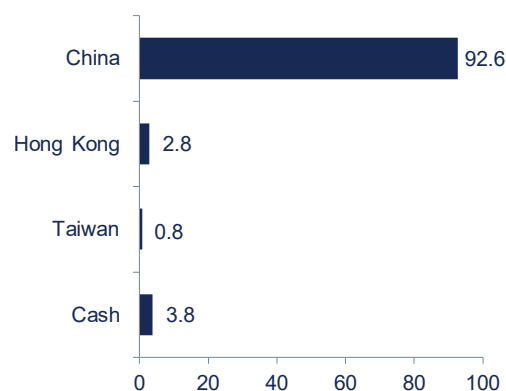
TOP SECTOR WEIGHTING (% OF MV)³
