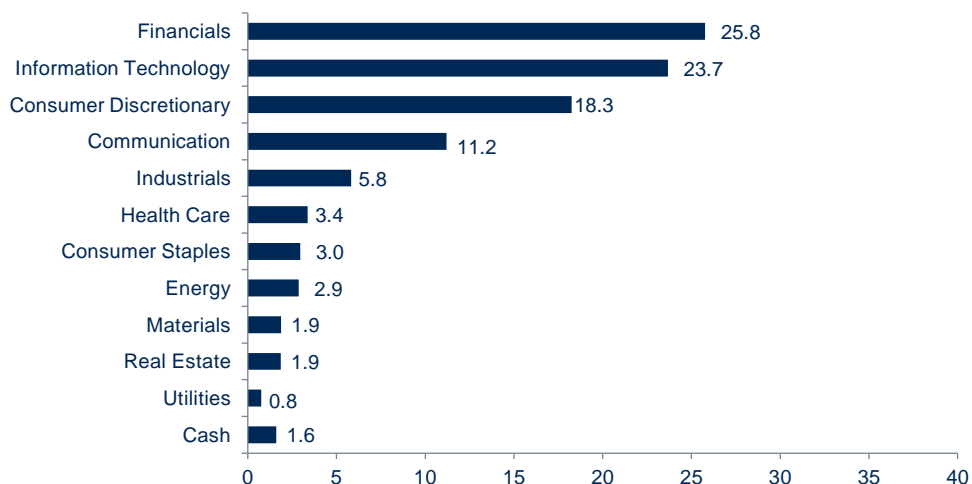

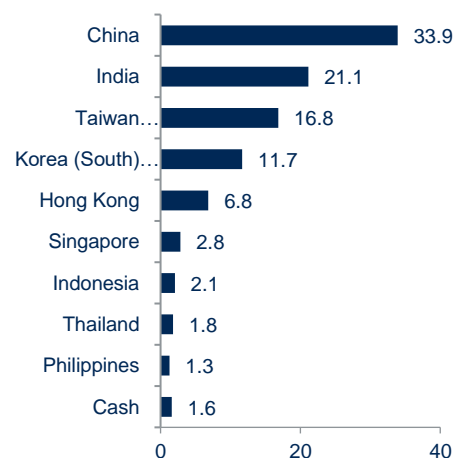
TOP SECTOR WEIGHTING (% OF MV)³
