KEY RISK

OBJECTIVE

The investment objective of the Barings Global Agriculture Fund is to achieve capital growth by investing in the agricultural sector.

STRATEGY & MARKETING OPPORTUNITY

The Fund has the flexibility to invest in companies from across the entire agricultural value chain - from planting to harvesting to delivering food to the table. Taking a long term (five-year) perspective, we avoid valuing agriculture companies on their peak or trough earnings but focus instead on their quality and long-term growth potential.

- A rising global population should lead to structurally increasing demand in grains and edible oils.
 Furthermore, the global middle class is forecast to double in size between 2015 and 2030 and this will likely lead to a shift in diets to consume more meat, fish and dairy which is grains intensive to produce.
- Investing across the agricultural value chain, from farm to fork, enables the Fund to access a diverse
 opportunity set of market-leading agriculture companies from across the globe.




