KEY RISK

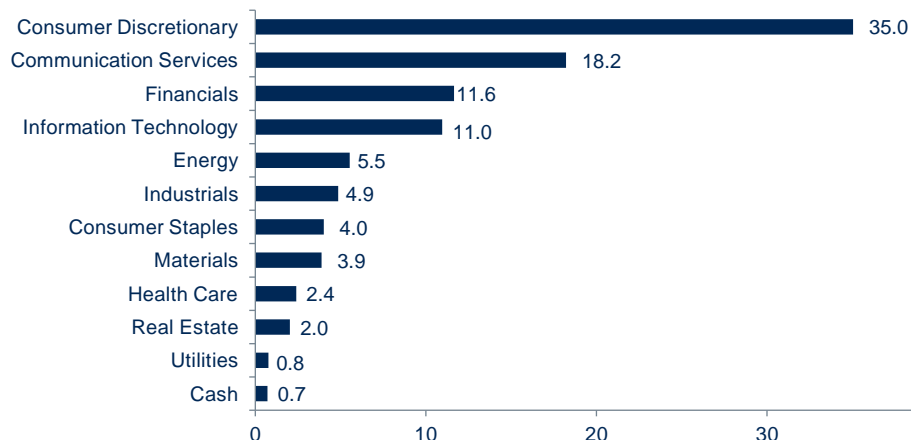

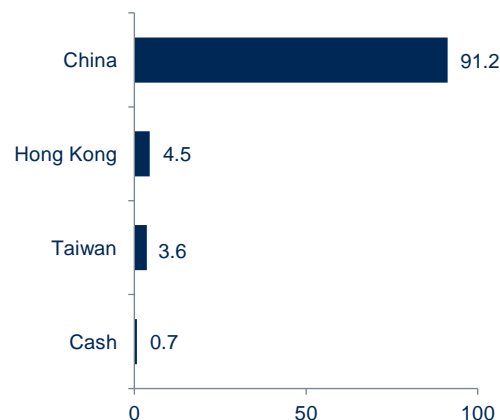
