KEY RISK

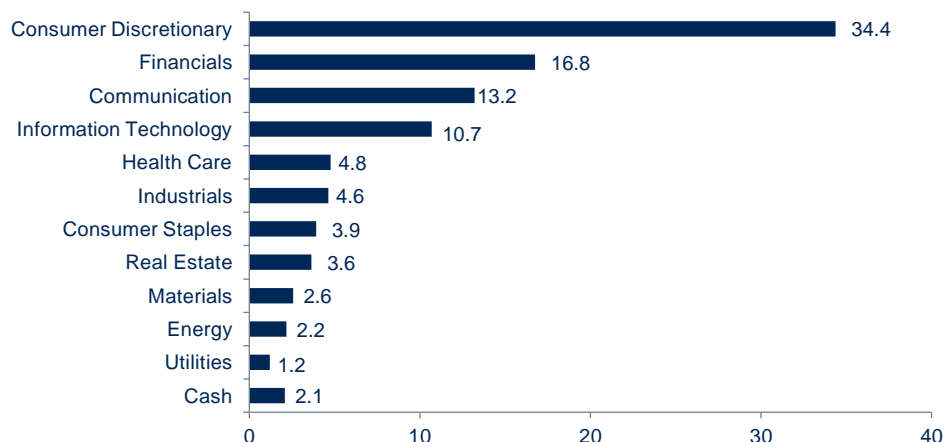

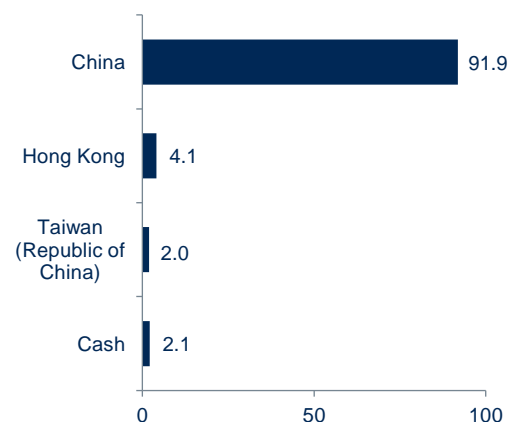
