KEY RISK

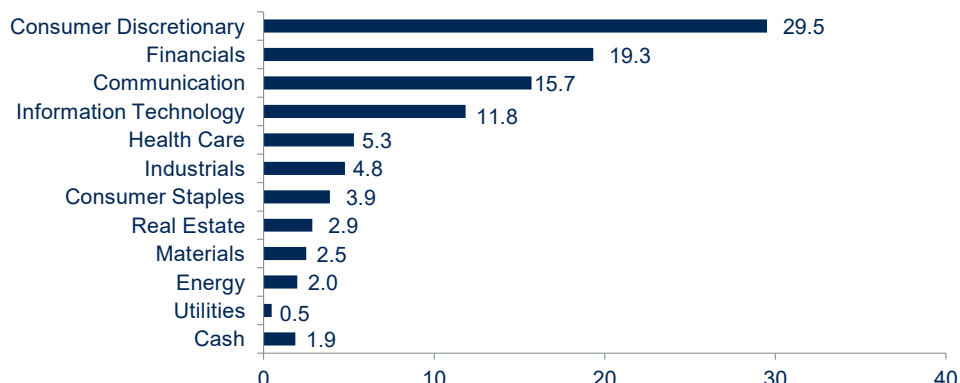

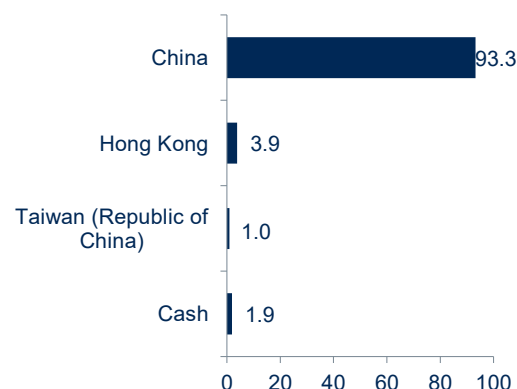
TOP SECTOR WEIGHTING (% OF MV)³
