KEY RISK

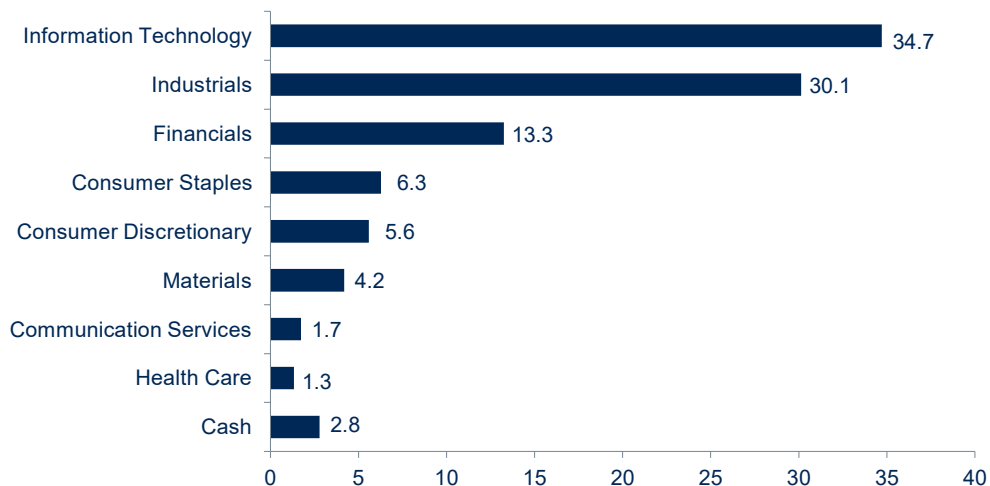
