KEY RISK

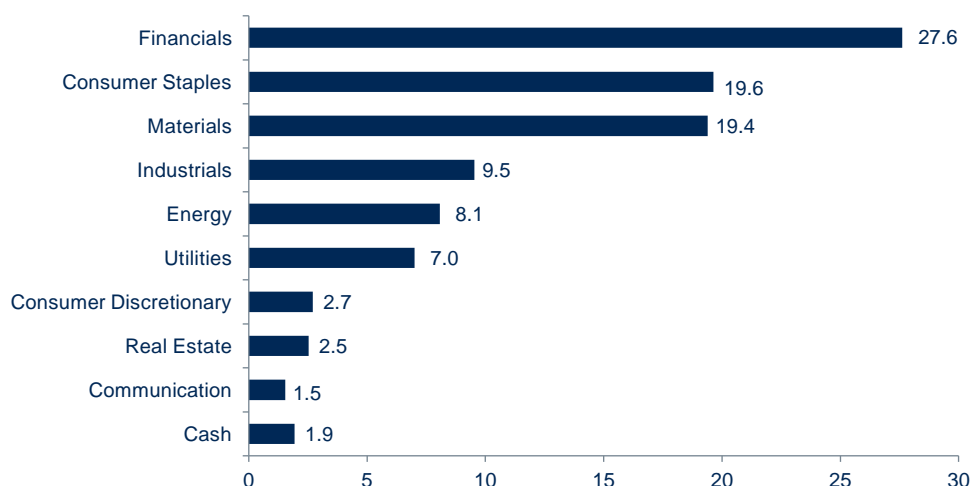
